

User Advisory Council starts its second term



15 representatives of all customer groups of the German Patent and Trade Mark Office appointed for four years – DPMA President: a place to discuss the burning issues our customers have

Munich. The User Advisory Council at the DPMA (DPMAnutzerbeirat) has today started its second term in a somewhat different composition. Due to the coronavirus pandemic, the advisory committee of the German Patent and Trade Mark Office (DPMA) held its first meeting in an online format. "Over the last two years, our User Advisory Council has proven to be a useful platform for the exchange of views and a helpful driving force," said DPMA President Cornelia Rudloff-Schäffer, adding: "We are very happy that we have been able again to recruit highly qualified members from all customer groups."

In addition to organisational issues, the first meeting focused on the use of artificial intelligence in patent examination and on the question to what extent hearings could be held as video conferences. According to the current plans, the committee will also discuss, among other issues, patent quality, the duration of examination procedures and new duties of the DPMA concerning the provision of information about IP rights to small and medium-sized enterprises. "We want to discuss the burning issues we and our customers have," the DPMA President emphasised. "We therefore hope that the members of our advisory committee will have as many purposeful ideas and suggestions as possible," she added. At the beginning of 2019, the senior management of the office created the committee as a key element of customer dialogue.
